Prioritising Patient Voices: Ensuring Health Policy Remains a Top EU Focus

As we close out August 2024, the European healthcare landscape continues to evolve. For us, at EPF, it is vital that health remains a priority in the EU agenda. Patients should have a say in policies that affect their health. But currently, most EU and national institutions fall short in guaranteeing early, meaningful and impactful involvement of patient organisations in health policy decision-making.

As our leaders show waning interest in fortifying health policies, patient organisations face the threat of losing support, including public funding, that is vital for civil society. We have recently elected new MEPs who will represent us in the EU for the next five years. Now is the time to make sure they keep health at the top of the EU agenda and guarantee patients to have a meaningful say in any related policy making.

While this is a reminder that progress has been made, the road ahead remains long. As we look forward to the coming months, it is clear that sustained efforts and innovative approaches will be essential in ensuring that all Europeans can enjoy equitable, personcentred, accessible, and sustainable healthcare systems, based on patients' unique expertise.
