Building a Healthier Future: Insights from the European Health Forum Gastein

As September wraps up, we get first-hand news and rich insights gained from the **European Health Forum Gastein**. This year, the European Patients' Forum (EPF) was represented by Anca Toma, Executive Director, and Julie Spony, Policy Officer, while Milana Trucl, Policy Officer, contributed to the *Special Eurohealth Gastein Issue*, with **an article on EHDS**.

At the heart of these discussions, Anca Toma engaged in several panels on safeguarding civil society participation in EU health policymaking, renewing Europe's social contract, and ensuring access to essential medicines. Simultaneously, Julie Spony brought fresh perspectives through her participation in the Young Forum Gastein programme.

In Anca Toma's words during the session on renewing the social contract, "Europe should prioritise not only economic competitiveness but also social competitiveness. Our historically well-performing social systems are under threat, and their sustainability can only be ensured if a broader range of voices are heard. Patient organisations play a crucial part in this, particularly in education, fostering democratic engagement, and improving health literacy."

From a patient organisation perspective, active civil society participation is indispensable for democratic policy-making. It urges a collaborative effort: governments must engage and sustain a vibrant civic space, while civil society organisations work to uphold transparency, accountability, and sound governance.
